### **Holy Family Catholic Community Annual Report for 2020**

Greetings in Christ,

We are approaching the end of 2020, and as we do every year at Holy Family Catholic Community, we take a look back at the preceding 12 months—the successes of our ministries, and where we would like to improve in the year to come—to form our Annual Report.

Of course, doing so this year is a bit different. As we started 2020, we looked forward to celebrations and festivities, like that of our 20th anniversary as a parish. We could not have envisioned that when we marked the death of Christ on Good Friday, and celebrated His Resurrection on Easter Sunday, we would do so with empty pews, but a crowded livestream. We would not have understood the level of joy that now comes with the ability to gather in-person this Christmas season—albeit at a social distance.

And yet, finding ways to continue to worship and serve during this pandemic has held us close to the heart of our mission: "We are a Catholic community empowered through the Holy Spirt to love God and to follow Jesus Christ through faith, worship, and witness."

Faced with many challenges, our parish staff, volunteers, and priests met them with thoughtful innovation and a Christ-like heart. To continue to offer Mass, the priest team and staff first worked together to navigate new technology and the livestream process, and later to bring our parishioners back to our pews safely.

With singing at mass discouraged, our Music and Liturgy Ministry continued to offer beautiful music at our Masses and on our Facebook page for Sacred Music Mondays. Our Christian Formation Team adapted to educate our students through take-home programs, virtual options, and staggered schedules, while also celebrating First Communions and Confirmations. Our staff and priest team stood with families in their sorrow as they grieved at this hard time, holding more than 90 funerals in our churches, and more than 60 at either a funeral home or cemetery. In July, we welcomed Presentation of the Blessed Virgin Mary and Our Risen Savior churches into our parish with a successful merger, strengthening our faith community.

In 2019, our Human Concerns ministry named one of its goals as continuing to support the vulnerable in 2020, and the year provided us more opportunities than ever to help those in our community. Early in the pandemic, we opened a temporary shelter at St. Mary Church to provide those without anywhere else to go a place to retreat from the cold weather. This fall, we began our meal program, Blessed Bites, which, with your donations, provides to-go meals, and care/cleaning items to anyone in need of them from St. Mary's every Monday.


In November, volunteers and staff rallied to put together and distribute our first Thanksgiving meal, feeding more than 400 in the Fond du Lac area. Just last week, we opened the St. Mary's Outreach Center out of the St. Mary's Rectory, offering shelter during the day for The Salvation Army Warming Shelter clients.

Throughout all this change, as you will see in this report, we were able to responsibly maintain our finances and keep all employees on staff with the help of generous donations from parishioners like yourselves. Now, as we turn our eyes towards 2021, we are doing so with a hope of health and a return to the celebrations we once knew, but also gratitude for you and for all that we were able to accomplish this year with your assistance.
