Holy Family Catholic Community Annual Report for 2021

Dear Holy Family Catholic Community,

As we stand on the cusp of the new year, I find myself thinking, among many things, about change. In the past two years, we've all experienced our fair share of it; in ways big and small, some heartbreaking, others bringing us closer to those we love. Change can be difficult, but it also offers an opportunity for gratitude. Last year at this time, we could not say what 2021 had in store, but we relied on God, knowing that He would show us the way through. We could not see all the accomplishments and moments of joy awaiting us, but the Lord could. But, as I see where the road has led us, I know I feel blessed.

2021 was, in many ways, a year of welcoming. As people felt more comfortable returning to Mass, we saw faces in our pews that we had not seen in a year, as well as some we had never seen before. Through the Sacrament of Baptism, we welcomed 165 of our youngest parishioners. Through RCIA, or the Rites of Christian Initiation, 12 children and adults became fully initiated in the Catholic Faith. After last year's virtual programming, students returned to our Summer Program and Vacation Bible School, ready to learn more about Jesus and their faith. St. Mary's Springs Academy K-12 Masses returned to Holy Family Church this fall, and are just one sign of the strong relationship between our parish and the school community. Our Hispanic community continues to grow and the ministry deepen, touching our entire parish with Mass celebrations like Día de los Muertos, our Lady of Guadalupe, and Deacon Ricardo's retirement/40th anniversary as a Deacon. Our Young Adults program grew in offerings, hosting nearly 70 events including field trips, praise and worship nights, and cocktail parties.

It was also a year of celebration. This spring, we celebrated the culmination of our Sacramental Preparation programs when 121 children received their First Communion and 113 teens were Confirmed. In October and December, we had the opportunity to bring our parish community and the community at-large together at our first-ever Oktoberfest, as well as at our returning Living Nativity. Throughout the year, our priest team and deacons joyfully officiated the weddings of 24 couples at our churches. With sadness and grief, we celebrated the lives of 189 friends, loved ones, and fellow parishioners as God brought them home.

As previously stated, it was a year of change—not only in what we experienced as individual, but also the change that we make to affect the lives of others through good deeds and spreading the Good News. Through our weekly Blessed Bites meal program, we served, 2,600 meals this past year, and our Holy Family Thanksgiving Meal alone fed 400 people in the Fond du Lac area. Now in our second season, the Holy Family Outreach Center, powered by staff and volunteers, serves those who are homeless in our community. In October, we sent out 91 care packages to students in college or engaged in a year of service, sharing with them treats, as well as opportunities for faith-filled connection near their school or in the parish when they return home.

You have also changed the lives of our priest team, including my own, through your support of our Holy Family Rectory Campaign. Believing in our mission to have all our Holy Family priests under one roof, sharing in faith and fellowship, you responded to our campaign with incredible generosity, and helped us reach our \$2 million goal. As renovations continue on the new rectory, we look forward to 2022 and welcoming you all for an open house this spring.


