**Financials**: Financial statements for the period ending April 30, 2021, were summarized by Ellen. Individual contributions are \$88,000 over budget year-to-date. Net surplus year-to-date is \$830,000 which includes bequests, PPP loan forgiveness, proceeds from sale of the Marquette St. house and PBVM school.

We're hoping to have the carpet replacement done by the end of June (Holy Family office entry and other areas). We will no longer receive rental income from the Marquette St. house and the music studio at Presentation. We will only have ORS rectory rent plus building usage rent. Since the merger with PBVM and ORS, we will incur additional expenses for utilities, property/liability insurance, etc. Ellen provided a Financial Highlights written report for April.

**Budget Process:** The final budget was reviewed & approved. Ellen will submit the budget in June.
