Additions to Agenda: SMSA Audit Review

<u>Financials</u>: Financial statements for the period ending September 30, 2022, were summarized by Ellen. Individual contributions are \$8,700 over budget year-to-date. Net Operating Deficit year-to-date was (\$52,000); Net Deficit was (\$47,000) compared to budgeted YTD deficit of (\$91,000). After non-cash transactions, net was a deficit of (\$106,000). Ellen provided a Financial Highlights report.

- Summer cash drawing income \$6,500 vs. \$9,400 last year
- Latin Flavor event net income approx. \$4,000
- Boiler maintenance-Sacred Heart \$5,700
- Handicap accessible door opener-Holy Family office, Dunphy funds \$7,600

<u>Fixed Asset Capitalization Policy</u>: Final policy was reviewed and signed.

**CFS Update**: Ellen reported it has been accepted; expecting \$50,000.

## Facilities Update:

- Our Risen Saviour septic system issues
- Sacred Heart rectory updates were made to meet fire code
- St. Peter's getting quotes for AC and heating

<u>Love One Another Archdiocese Campaign Update</u>: Fr. Ryan reported that we are now in the public phase of the campaign. \$1.5 million has been pledged in the initial phase by 1% of our parishioners. Witness talks will be given in December at masses.

<u>St Mary's Spring Academy Audit Review</u>: Dave K. reported that the SMSA audit through the end of June has been completed. Financial results are positive. The school is appreciative for the use of Holy Family's storage facility.
