**Financials**: Financial statements for the period ending January 31, 2023, were summarized by Ellen. Individual contributions are \$24,000 over budget for January; \$163,000 over budget year-to-date. Net Operating Surplus & Net Surplus for January was \$1,110, compared to budgeted monthly deficit of \$25,000. After non-cash transactions, net was a surplus of \$29,000. Ellen provided a Financial Highlights report.

- Bequests year-to-date \$32,209
- Investment income in January \$3,148
- St Peter rectory is being rented out short-term (6 month lease) \$700/month
- Our Risen Saviour rectory is being rented out \$600/month
- Snow removal in January is \$10,000 higher than Jan 2022
- Sacred Heart windows \$14,200
- Holy Family Lighting project dimmer rack was on backorder, \$11,000

**<u>Budget</u>**: Ellen has started the process.

Love One Another Archdiocese Campaign Update: Fr. Ryan reported Holy Family has raised \$3.3 million; 76% of our goal; 14% participation.

### Parish Updates:

- Fr. Edward will be leaving; Interviewing for his replacement has started
- Euchre Tournament, Feb 5, went well
- Two refugee families are transitioning out of St Mary rectory. Three other families will be moving in soon.

John asked about donating to the Turkey & Syria earthquake victims. Fr Ryan will discuss this with Erin.
