<u>Financials</u>: Financial statements for the period ending September 30 were summarized by Ellen. Individual contributions were \$10,000 over budget for September; \$18,000 over budget year-to-date. Net operating deficit was (\$48,000), compared to budgeted monthly deficit of (\$21,000). We had other expenditures of \$174,000 (for warming shelter, to be refunded by donor pledges). Net deficit (\$222,000). After other non-cash transactions, net was a deficit of (\$265,000). Ellen provided a Financial Highlights report.

- <u>Facility Master Plan</u> A 5-20 year plan is being developed based on the study that was done in 2020. A committee has been formed of six members from the parish. Their first meeting will be next week. Excel Engineering is helping with the planning.
- <u>Warming Shelter</u> Still in need of volunteers. Construction is being done by Capelle's. They are on schedule. Shelter to open Nov. 15. Security system is being installed. Manuel has been hired as the shelter coordinator. We have petitioned the county for additional funding.
