<u>Financials</u>: Financial statements for the period ending February 29 were summarized by Ellen. Individual contributions were \$8,000 over budget for February; \$156,000 over budget year-to-date. Net operating deficit was (\$67,000), compared to budgeted monthly deficit of (\$43,000). After other non-cash transactions, net was a deficit of (\$23,000). Year-to-date net operating surplus was \$507,000 vs budgeted \$126,000. After other receipts/expenditures and non-cash transactions, net was a surplus of \$617,000.
